**REVISED DRAFT REGULATIONS GOVERNING LATERAL
ENTRY TO THE SCHEMES OF CBCS AND / OR FOUR - YEAR
UNDER GRADUATE DEGREE PROGRAMMES AS PER NEP-2020
AND / OR NEP (REVISED) FOR KARNATAK UNIVERSITY,
DHARWAD**

Effective from 2021-22

REGULATIONS

"Regulations governing Lateral Entry to the Schemes of CBCS and / or 04 - Year Under Graduate Degree Programmes as per NEP-2020 and / or NEP(Revised) for Karnatak University, Dharwad"

PREAMBLE:

Karnatak University, Dharwad has duly implemented Three -Year Under Graduate Programmes under CBCS, Four -Year Under Graduate (Hon) Programmes under NEP and Three -Year Under Graduate Programmes under NEP Revised w.e.f 2020-21, 2021-22 and 2024-25 respectively. Further, in continuation of these Regulations, the following supplementary Regulations have been framed to facilitate the Lateral Entry from Non- CBCS scheme to higher Semesters of CBCS/NEP, CBCS to NEP / NEP (Revised) and NEP to NEP (Revised) Schemes.

1. TITLE AND COMMENCEMENT

- a. These Regulations shall be called **"Regulations governing Lateral Entry to the Schemes of CBCS and / or four - year Under Graduate (Hon) Degree programmes as per NEP-2020 and / or NEP (Revised) for Karnatak University, Dharwad"**.
- b. These Regulations are framed pursuant to the power conferred under section 44(1a &d)) of K.S.U. Act 2000
- c. These Regulations shall come into effect from the Academic Year: 2021-22 after H.E. the Chancellor's assent.

2. DEFINITION:

- a. "Non - CBCS Scheme" means the Scheme of 03 / 04 -Year U.G. Degree Programme which was in force prior to the introduction of CBCS Scheme.
- b. "CBCS Scheme" means the Scheme of 03/ 04 -Year U.G. Degree Programme which was in force prior to the introduction of NEP-2020.
- c. "NEP Scheme" means the Scheme of 04 - Year (Hon) U.G. Degree Programme which is implemented from the Academic Year: 2021-22.

- d. "NEP (Revised) Scheme" means the Scheme of 03 - Year U.G. Degree Programme which is implemented from the Academic Year: 2024-25.
- e. "Lateral Entry" means a student who have discontinued from Non-CBCS / CBCS / NEP Scheme and any other schemes in future seeking re-admission to 3 / 4 - Year U.G. Degree programmes under CBCS / NEP / NEP (Revised) Scheme.

3. APPLICABILITY FOR LATERAL ENTRY

- a. **Three - Year U.G. Degree programmes (Semester scheme):** B.A., B.Sc., B.Com. B.Com.(CS), B.B.A., B.C.A., B.Sc.(CS). B.Sc(HM), B.P.A.(Music), B.S.W. B.T.A. / B.T.T.M. and any other Programmes introduced in future.
- b. **Four - Year U.G. Degree programmes (Semester scheme):** B.V.A, B.Sc. (Pulp & Paper) and B.A.S.L.P. Programmes.
- c. **Three - Year B.A. (ILRD) (Non- Semester).**

4. PROVISIONS FOR LATERAL ENTRY:

There shall be a provision for Lateral Entry for the students who have discontinued their education and are aspiring to continue from various Schemes as detailed below.

- a. **Three - Year U.G. Degree programmes (Semester scheme):**
 - i. **Admission from Non - CBCS to CBCS Scheme:** The students studied the first two / four Semesters under Non- CBCS Scheme shall be eligible to seek admission for 3rd / 5th Semester as per CBCS scheme in the Academic Year 2021-22 / 2022-23. Failing which students shall have to seek Lateral Entry under NEP scheme.
 - ii. **Admission from CBCS to NEP Scheme:** The students studied the first two / four Semesters under CBCS Scheme shall be eligible to seek admission for 3rd / 5th Semester as per NEP Scheme in the Academic Year 2022-23 / 2023-24 onwards.

- iii. **Admission from Non - CBCS to NEP scheme:** The students studied the first two / four Semesters under Non - CBCS Scheme shall be eligible to seek admission for 3rd / 5th Semester as per NEP Scheme in the Academic Year 2022-23 / 2023-24 onwards.
 - iv. **Admission from CBCS / NEP to NEP (Revised) Scheme:** The students studied the first two / four Semesters under CBCS / NEP Scheme shall be eligible to seek admission for 3rd Semester as per **NEP(Revised)** Scheme in the Academic Year 2025-26 onwards; and 5th Semester as per **NEP(Revised)** Scheme in the Academic Year 2026-27 onwards.
- b. Four - Year U.G. Degree programmes (Semester scheme):**
- i. **Admission from Non - CBCS to CBCS Scheme:** The students studied the first two / four / six Semesters under Non- CBCS Scheme shall be eligible to seek admission for 3rd / 5th / 7th Semesters as per CBCS Scheme in the Academic Year 2021-22 / 2022-23 / 2023-24. Failing which students shall have to seek Lateral Entry under NEP scheme
 - ii. **Admission from CBCS to NEP Scheme:** The students studied the first two / four / six Semesters under CBCS Scheme shall be eligible to seek admission for 3rd / 5th / 7th Semester as per NEP Scheme in the Academic Year 2022-23 / 2023-24 / 2024-25 onwards
 - iii. **Admission from Non - CBCS to NEP scheme:** The students studied the first two / four / six Semesters under Non - CBCS Scheme shall be eligible to seek admission for 3rd / 5th / 7th Semesters as per NEP Scheme in the Academic Year 2022-23 / 2023-24 / 2024-25 onwards.
 - iv. **Admission from CBCS / NEP to NEP(Revised) Scheme:** The students studied the first two / four / six Semesters under CBCS/NEP Scheme shall be eligible to seek admission for 3rd Semester as per NEP(Revised) Scheme in the Academic Year 2025-26 onwards: 5th Semester as per NEP(Revised) Scheme in the Academic Year 2026-27 onwards: 7th Semester as per NEP(Revised) Scheme in the Academic Year 2027-28 onwards:

c. B.A. (ILRD) (Non- Semester Scheme): The students studied 1st / 2nd year shall be eligible to seek admission for 3rd / 5th Semester under NEP Scheme in the Academic Year 2022-23 / 2023-24 & onwards.

d. B.Sc.(CS) (Semester scheme) :

i. **Admission from Non - CBCS to CBCS Scheme:** The students of B.Sc.(CS) who have studied the first two / four Semesters under Non-CBCS Scheme shall be eligible to seek admission for 3rd / 5th Semester as per CBCS Scheme in the Academic Year 2021-22 / 2022-23. Failing which students shall have to seek Lateral Entry under NEP Scheme as per the provision of 4d (ii).

ii. **Admission from CBCS to NEP Scheme:** Since B.Sc.(CS) is discontinued under NEP Scheme, the students shall be eligible to seek admission with Computer Science as major and Mathematics as minor for 3rd / 5th Semester under NEP Scheme in the Academic Year 2022-23 / 2023-24 & onwards..

e. Any student who is admitted Laterally for the U.G. Degree programs under NEP Scheme has to study compulsorily all the Skill Enhancement Courses (SEC) of previous Semesters through on-line mode.

f. The students of B.A. and B.Sc. Programmes sought admission through Lateral Entry under NEP Scheme shall have to choose any two optional papers out of the three papers studied in the previous year as Discipline Specific Core Course (DSCC) and the remaining paper shall be considered as Open Elective Course (OEC).

g. The students of B.A. and B.Sc. Programmes sought admission through Lateral Entry under NEP (Revised) Scheme shall have three optional papers out of the two papers studied in the previous year under NEP Scheme as Discipline Specific Core Course (DSCC) and Open Elective Course (OEC) of the NEP shall be 3rd DSCC in NEP (Revised).

- h. The students of B.A. and B.Sc. Programmes sought admission through Lateral Entry under NEP (Revised) Scheme shall have to study the same three optional papers studied in the previous year under CBCS Scheme as Discipline Specific Core Course (DSCC).

5. EXAMINATION:

a. Lateral Entry from Non- CBCS to CBCS Scheme:

- i. Examination results shall be declared in terms of percentage of marks in lieu of CGPA.
- ii. Degree shall be awarded as per the provisions of Non- CBCS Regulations.

b. Lateral Entry from CBCS to NEP Scheme:

- i. Examination results shall be declared in CGPA.
- ii. Degree shall be awarded as per the provisions of NEP Regulations provided the student has passed the SEC of previous Semester / s through on-line mode. Otherwise, the results shall be declared as per CGPA Regulations.

c. Lateral Entry from Non- CBCS to NEP Scheme:

- i. Examination results shall be declared in terms of percentage of marks.
- ii. Degree shall be awarded as per the provisions of NEP Regulations provided the student has passed the SEC of previous Semester/s through on-line mode. Otherwise, the results shall be declared as per Non- CBCS Regulations.

d. Lateral Entry from CBCS / NEP to NEP (Revised)Scheme:

- i. Examination results shall be declared in CGPA.
- ii. Degree shall be awarded as per the provisions of NEP (Revised) Regulations.

6. MAKEUP EXAMINATION, RANKS / GOLD MEDAL AND DURATION OF COMPLETION OF PROGRAMME

- a. Students can write the examination for the subjects due if any, in accordance with pre-lateral entry scheme. However, there shall not be any provision for improvement of marks under Pre-Lateral Entry Scheme.
- b. University shall not consider the Lateral entry students for Ranks / Gold medals.
- c. There shall be a provision of '**Double the Duration**' for completion of the prescribed degree as Per Pre-Lateral Entry Schemes.

7. REPEAL AND SAVINGS

- a. Notwithstanding anything contained in these regulations, any of the provision, guidelines, order, rules or regulations which are in force, shall be inapplicable to the extent of their inconsistency with these Regulations.
- b. University shall issue such orders, instructions and prescribe such format, procedures, etc. as it may deem fit to implement the Provisions of these Regulations.
- c. In event of any ambiguity/conflict arising in the interpretation of these Regulations, the decision of the Vice- Chancellor shall be final.
- d. Further, in the event of any new schemes introduced in future as directed by the Government of Karnataka / UGC, the Vice Chancellor decision with the due approval from the Academic Council shall be final for the admission eligibility and award of degree for such lateral entry students from old schemes to new schemes.
