This is to inform that the NAD (National Academic Depository) team has provided a final opportunity to push the pending marks card data for the academic years 2021 to 2024 to the NAD Portal.

Our University has already pushed the majority of the students' marks card data successfully. However, some records have failed during the process due to the following reasons:

SL. No.	Reason for Failure	Solution
1	ABC ID Not exit	Students need to create ABC ID
2	Wrong ABC ID approved by PG Department and Coordinator in UUCMS	Edit in Principal login
3	Date of birth is not updated, EMAIL	Students need visit university UUCMS team with SSLC marks card
4	Name mismatch ,MOBILE	Revalidation Aadhar
5	APAAR e-KYC Pending.	Approve the ABC ID in UUCMS principal Login

All Principals PG Department Chairman and Coordinator/Administrator are informed to instruct the concerned students (2021–2024 batch) to create their ABC IDs immediately and ensure that the same are approved in UUCMS through Principal login without any delay.

The last date for pushing marks card data to the NAD Portal is 30-11-2025. This is the final chance, and no further extension will be provided by the NAD team.

If any student's data fails to be pushed due to non-creation or non-approval of ABC ID, the concerned Department, Coordinator, and Student will be held responsible.

You are therefore informed to take immediate action to ensure that all student data is complete and ready for the final push to NAD.

Subject: Request for Extension of Timeline and Reopening of Upload Window for academic records (Examination Years 2021-2024) on the NAD-ABC Platform - regarding

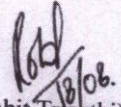
Sir,

2. In this regard, it may be noted that the earlier deadline for uploading the academic records was fixed as 30th June, 2025. However, keeping in view the representations received from several State Governments seeking a one-time relaxation for the aforementioned purpose, the competent authority has accorded approval for the reopening of the upload window till 30th November 2025.
