CIRCULAR

Subject: Creation and Approval of Academic Bank of Credits (ABC) ID and Upload of Academic Records to NAD/ABC Platform – Reg.
Ref: MoE DoHE to State HE ABC dated 29.05.2026

It is hereby informed to all Principals of Constituent and Affiliated Colleges, Chairpersons of PG Departments, and Coordinators/Administrators of Karnataka University, Dharwad, that the Ministry of Education has directed all Credit Awarding Institutions to upload academic records, including marksheets/grade sheets and corresponding credit data pertaining to Examination Year 2025 on the NAD/ABC Platform on or before 30-06-2026.

In this regard, all concerned are instructed to ensure that every eligible student creates an Academic Bank of Credits (ABC) ID immediately. Further, the created ABC IDs must be verified and approved through the UUCMS Principal Login without any delay.

The schedule prescribed for compliance is as follows:

1. Last Date for Creation and Approval of ABC IDs through UUCMS: 15-06-2026.
2. Karnatak University, Dharwad will commence the process of uploading/pushing academic records, including marksheets/grade sheets and corresponding credit data, to the NAD/ABC Platform from 16-06-2026 onwards.
3. Last Date for Upload of Marksheets/Grade Sheets and Corresponding Credit Data to NAD/ABC Platform: 30-06-2026.

All Principals, Chairpersons, Coordinators, and Administrators are requested to communicate this information to all students concerned and take necessary steps to ensure 100% compliance within the stipulated timelines.


It may be noted that academic records cannot be successfully uploaded to the NAD/ABC Platform without a valid and approved ABC ID. Since the University will begin pushing academic records from 16-06-2026, all institutions must ensure that the ABC IDs of their students are created and approved on or before 15-06-2026.

Further, if any student's academic records fail to be uploaded to the NAD/ABC Platform due to non-creation or non-approval of the ABC ID within the prescribed timeline, the concerned student and the respective Principal/Head of the Institution shall be held responsible for the delay.

All concerned are hereby directed to treat this matter as MOST URGENT and ensure strict compliance.

Kindly refer to this ministry D.O. No. 16-5/2020-TEL-Part (4) dated 07-11-2024 regarding the implementation of the Academic Bank of Credits (ABC) and importance of the **timely upload** of **student academic records** and **credit data** on the NAD/ABC repository.

2. Timely upload of academic records with APAAR ID is essential for the effective implementation of the Academic Bank of Credits ecosystem and to facilitate seamless credit accumulation, transfer, redemption, and other student-centric services.


3. It is hereby informed that all credit awarding institutions are required to upload academic records, including marksheets/grade sheets and corresponding credit data, pertaining to **Examination Year 2025** on the NAD/ABC platform by **30th June 2026**. After the deadline, the upload window will be closed, and no further fresh uploads for Examination Year 2025 shall be permitted on the platform. However, **corrections or modifications** to already uploaded records may be permitted only in exceptional cases and in accordance with the prescribed procedures of the NAD/ABC system.

4. You are requested to review the current status and instruct all **Universities, Autonomous Colleges, and Stand-alone Institutions** in your state to ensure the upload of academic records, including marksheets/grade sheets and corresponding credit data, pertaining to Examination Year 2025 on the NAD-ABC platform within the prescribed timeline.
