

Applicants may apply through UUCMS Admission Portal https://uucms.karnataka.gov.in/. and on payment of Rs.500/-(Rs.250/- for SC,ST & Cat-I) in form of DD. The DD Should be in favour of "The Principal, KUSSK Law College, Dharwad", a hard copy of the uploaded application and attached documents should be submitted to the under signed along with DD within the last date compulsorily. The DD date should be within the last date of submission of Application.

2. Compulsorily a hard copy of the uploaded application and attached documents along with D.D has to be submitted to the college within the last date. Further if hard copy of applications along with documents not submitted within time will not be considered for merit list for admission.

3. Incomplete applications and applications submitted after last date will be rejected.

4. The selection of the candidates will made only on merit cum roster as per the University norms/ Government of Karnataka.

5. Selected candidates should compulsorily attend the document verification with all the original documents and should pay the prescribed admission fees at the time of counseling.

6. The admitted candidates are required to submit the application, challan and other necessary documents to the college compulsorily. Otherwith will not be consider to admission.
