# Regulations for PG II and III semester Open Elective Course in Gandhian Studies course Karnatak University Dharwad

(Framed under Section 44(1)(c) of the K. S.U. Act, 2000)

### 1.0 Title

These Regulations shall be called "Regulations Governing of the PG II and III semester Open Elective Course in Gandhian Studies in Gandhian Studies (PGDGS) at Karnatak University".

# 2.0 Commencement

These Regulations shall come into effect from the date of assent by His Excellency, the Chancellor of the University.

### 3.0 Definitions

In these Regulations, unless otherwise provided:

The Course shall be called "P. G. Diploma in Gandhian Studies" (PGDGS)

- A "Academic Council" means Academic Council of the University constituted according to the Karnataka State Universities Act, 2000.
- **B "Board of Studies"** means P.G./ U.G. Board of Studies in respective subjects of Karnatak University, Dharwad.
- C "University" means Karnatak University, Dharwad.
- **D** "Course" means subject or papers having specified units which go to comprise a specified programme of study.

The Course shall be called "P. G. Diploma in Gandhian Studies" (PGDGS) with Semester System.

E "Credit" means the standard methodology of calculating teaching

hours of the course per week in the semester system.

- i. One credit is equal to One Hrs Theory teaching per week.
- ii. One Credit is equal to 15 Hrs Theory Syllabus per semester (1Unit is equal to 15 Hrs).
- **F "Candidate"** means, a person seeking admission or appearing for examination to the P.G Diploma in Gandhian Studies (PGDGS).
- **G "Student"** means a person admitted to, and pursuing, a specified credit based course/programme of study in a higher education institution.

# 4.0 Workload for practical subjects

- 1. There shall be 60 hrs/week workload for Assistant Professor
- 2. There shall be 14 hrs/week workload for Associate Professor/Professor/Senior
- 3.Professor. There shall be 2hrs/week workload relaxation for Guiding Ph.D. students

# 5.0 Marks and Conduct of Examination

- 1. Generally, 25% weightage for Formative assessment and 75% weightage for Summative assessment
- 2. Up to 2 credits equal to 50 marks (10 marks Formative assessment and 40 marks summative assessment)
- 3. 3-4 credits equal to 100 marks(25 marks Formative assessment and 75 marks summative assessment)
- 4. 5-6 credits equal to 150 marks(30 marks Formative assessment and 120 marks summative assessment)
- 5. Example for 100 marks out of which 25 marks for Formative assessment i.e., Formative Assessment shall be in two internal assessments i.e.: 10 marks I.A. for 8<sup>th</sup> week and 10 marks for 14<sup>th</sup>week of every semester and 05 Marks for Assignment / Tutorial / Book review / Seminars.
- 6. 75% attendance is mandatory for every course(paper). No marks are reserved for attendance. If the candidates fails to fulfils 75% attendance in any one of the course (paper) in the given semester, such candidate is not eligible to appear for examination in all the papers and candidate has to get the readmission for such semester.
- 7. Passing criteria: Candidate has to score minimum 40% in summative examination and fulfill 40% of the maximum marks including Formative assessment marks. For example: for 75 marks summative examination, candidate has to score minimum of 30 marks(40%) and should score cumulatively 40 marks including formative assessment.
- 8. Candidate has to score 40% as above in all the courses to pass the semester end examination.
- 9. Marks obtained from the OEC shall not be considered for award of CASH PRIZE / RANK / GOLD MEDAL.
