- 2. BA/B.Sc. I-VI Semester Marks Cards (Net copies must be attested by the concerned College Principal)
- 3. Valid Caste Certificate and Income Certificate (For SC/ST/Cat-I/II-A/II-B/III-A/III-B candidates)
- 4. Hyderabad Karnataka (HK) Region Certificate (371J) (if applicable)
- 5. Certificates for NSS/NCC/Sports/Children of Ex-Servicemen/Political Sufferers (if applicable)
- 6. Differently Abled Person Certificate (if applicable)
- 7. Free ship Card (SC and ST Candidates Only)

### 1. Migration and Eligibility Certificates:

Students from other universities, including Akkamahadevi Women's University (AWU) Vijayapur, must necessarily submit an Eligibility Certificate issued by the Academic Section of Karnatak University, Dharwad, within 7 days from the date of their admission. Failure to do so will result in the cancellation of their admission. Additionally, students are required to submit the Migration Certificate from their respective universities immediately after admission.

#### 2. Marks Cards Submission:

We are aware that many students have not yet received their **original mark cards**. In such cases, students must bring **UUCMS Marks Cards** that are **attested by the concerned College Principals**. Please ensure that these attested mark cards are submitted during the Admission Counselling process to complete the necessary documentation.

Candidates whose **Sixth Semester results** or previous semesters' results (2nd, 3rd, 4th, or 5th Semester) are still **pending** are requested to **wait** until **Round-III of Admission Counselling**, scheduled for **03**<sup>rd</sup> **October 2025**. Your admission process will be considered in Round-III once the pending results are available

## 4. Fee Structure and Payment Details:

4.1 Normal Fee Structure (Applicable to KUD and AWU Vijayapur students)

General Merit (GM), OBC, SC-ST (with income above ₹2.50 lakh), CAT-I: ₹14088
SC and ST candidates (with income below ₹2.50 lakh): ₹14088/-

**4.2** Enhanced Fee Structure (Applicable to Other Universities within the state and Other State students (including RCU):

General Merit (GM), OBC, SC-ST (with income above ₹2.50 lakh), CAT-I: ₹41,999/-SC and ST candidates (with income below ₹2.50 lakh): ₹41,999/-

#### 5. Special Note on Fees Structure:

All students are hereby informed that those who belong to Scheduled Caste (SC) category and other communities with an annual family income below ₹2,50,000/- must apply for the SSP Scholarship. The sanctioned scholarship amount will be directly credited to their respective bank accounts. Hence, from the academic year 2025–26 onwards, all SC and ST students are required to pay the full fees at the time of admission. Students are advised to make a note of this and ensure timely application for the SSP Scholarship to avail the benefit.

After remitting the fee, candidates must submit the **original paid receipt** along with **two photocopies** of the receipt. Candidates are required to pay the fees **at the time of counselling**. Failure to do so will result in the **cancellation of their seat**, which will be allotted to the next eligible candidate on the merit list.

Please note that failure to complete the full payment within the stipulated time will result in the cancellation of admission.
